

# Growing together: Mexico firms join forces to develop custom external audit system

This joint effort reflects the strong spirit of collaboration among MGI firms in Mexico, creating a practical solution that benefits all member firms.

Initiated by Nyssen Consultores Asociados of Cuernavaca, this collaborative project has brought together all 11 of the MGI Mexico member firms. In particular, the Nyssen team has worked closely with members Zesati Contadores and Alberto Rocabert y Cía.

#### Development of external audit module

**Jorge Rodríguez**, Partner at Nyssen shares how the initiative came about.

"At Nyssen Consultores Asociados, we developed a system to manage Internal Control Models called SCIRA (Internal Control, Risk, and Audit System), which includes various modules—one of them being the Internal Audit module. While reviewing how external audits were being managed, we noticed that several MGI Mexico firms had adopted external systems that came with high costs, were difficult to use, and lacked integration. That's when we decided to create a dedicated module within SCIRA for managing external audits, taking advantage of the platform we already had in place."

## From internal use to collaborative development

Initially, the module was intended for internal use within the firm. However, after regular discussions among the MGI firms in Mexico and a shared recognition of similar challenges, the decision was made to open the project to broader participation.

This **collaborative** approach allowed for valuable input from across the network, enriching both the development process and the tool itself.

#### Presentation and prototype development

The project was first presented at an MGI Mexico Assembly. Following that, the Nyssen team held meetings with Despacho Zesati.

Together, they analysed the proposal and suggested improvements, which led to the development of a working prototype.

#### Ongoing engagement and review

At the most recent MGI Mexico Annual Assembly held in March, the prototype was formally introduced, and all member firms were invited to continue contributing ideas and suggestions. A detailed review session is currently being coordinated with Alberto Rocabert y Cía.
